

***A Citizen Petition Calling for the Immediate Repeal of the
Patient Protection and Affordable Care Act*** (HR 3590)

Also Known as Obama Care

Whereas, it is fundamental to our entire system of government and checks and balances, that the rule of law, the restraint of arbitrary power, is absolutely fundamental. The concepts and ideas of the U. S. Constitution are the "higher law" (*Supreme Law of the Land*) in the United States of America, things that a government cannot create or destroy. Among these concepts and ideas is the notion that the people are sovereign and that legitimate governments must be based on the foundation of individual liberty. The U. S. Constitution is a document, in both word and deed, created by and for "we the people", establishing unalterable, unalienable, individual rights, as endowed by our Creator. If those in power determine that they do not have to follow the Supreme Law of the Land, or that they are above it, there can be no freedom, no liberty and no property rights, thus no individual, unalienable rights at all and no sovereignty; where government becomes completely arbitrary and capricious and America and its wealth and resources are for sale to the highest bidder, and

Whereas, for almost 100 years or longer, American Presidents and members of the U. S. Congress, along with state and local politicians, have systematically violated the Supreme Law of the Land, the U. S. Constitution, as well as the state constitutions to which they swear on solemn oath to preserve, protect and defend. They have felt empowered to do so because they were either arbitrarily disposed to do it, or rationalized such unconstitutional actions by virtue of declared or undeclared emergencies, that in fact may or may not be real emergencies, or emergencies that they themselves created, and

Whereas, we, signers of the petition on the backside hereof, do allege that the current administration under President Barack Obama and the 111th Congress of the United States, under Speaker of the House Nancy Pelosi and Majority Leader in the Senate Harry Reid, have overtly, blatantly and without authority, usurped their enumerated powers, issuing executive orders, passing law after law in the form of bailout legislation, stimulus packages, budgets, omnibus spending bills, the nationalization of banks, businesses and car companies, in addition to nationalizing the entire American Health Care industry under the "***Patient Protection and Affordable Care Act***" (*hereinafter referred to as HR 3590*), also known as Obama Care, containing confusing, conflicting and obfuscating language in well over 2,000 pages, most of which contains no constitutional authority whatsoever, and

Whereas, the attorneys general of over 20 states have sued the federal government in U. S. District Court, Florida, alleging that HR 3590 is patently unconstitutional, and

Whereas, several other states have passed laws to shield their citizens from the effects of HR 3590, and

Whereas, one College has sued the federal government on violation of First Amendment protections of religious freedom, and

Whereas, there is no constitutional authority for the federal government to force an American sovereign individual to purchase anything, and

Whereas, the petitioners strongly believe that HR 3590 is unconstitutional on its face and is therefore null and void. Being null and void, the petitioners are calling for its immediate repeal, and

Whereas, the petitioners further allege that the President and the U. S. Congress acted in direct violation of their solemn oath to preserve, protect and defend the Constitution of the United States and they did so in spite of overwhelming opposition to HR 3590 by the American people.

NOW THEREFORE, BE IT RESOLVED THAT, we, the petitioners, being sovereign and legal citizens of the United States of America, with our original signatures affixed to the backside hereof, do hereby call on the U. S. Congress to immediately repeal HR 3590, without further delay.
